# Whole Person Care (WPC) Pilots: State to Open Second Round of Pilot Applications

The Department of Health Care Services (DHCS) announced in mid-October that it will accept a second round of applications for Whole Person Care (WPC) pilot projects. The second round of applications is due on March 1, 2017.

WPC pilots are part of the Medi-Cal 2020 Section 1115 demonstration waiver, approved in December 2015 by the federal Centers for Medicare and Medicaid Services (CMS). The general requirements for the second round of applications will remain the same, but DHCS plans to update the second round of applications based upon lessons learned from the first round, which is expected to conclude in late October.

During the second application period, applicants may amend applications already approved in the first round to add new target populations and/or services and interventions. New applicants also may apply. Additional guidance will be provided prior to the release of the second round of applications.

# Filing and Ethics Requirements for Healthcare District Trustees and Executives

#### Form 700: Statements of Economic Interests

Every elected official and public employee who makes or influences governmental decisions is required to submit a Statement of Economic Interest, also known as the Form 700. The Form 700 provides transparency and ensures accountability in two ways:

- 1. It provides necessary information to the public about an official's personal financial interests to ensure that officials are making decisions in the best interest of the public and not enhancing their personal finances.
- 2. It serves as a reminder to the public official of potential <u>conflicts of interest</u> so the official can abstain from making or participating in governmental decisions that are deemed conflicts of interest.

#### Filing a Form 700

The FPPC is available to answer any questions you may have on Form 700 reporting or filing. However, in order to better assist you, you should obtain your "disclosure category." A disclosure category is a description of the types of financial interests you must disclose on your Form 700 based on your job classification or position. Each agency defines its own disclosure categories for each position based on the type and scope of work performed.

To obtain a copy of your disclosure category, check with a supervisor or other designated staff in your agency's legal or personnel department.

#### **AB 1234 Ethics Training**

Many public officials are required to take an ethics training course to educate them on the ethi cal standards required of any individual who works in state or local government. Public officials may utilize free online courses available to satisfy this requirement. Please note that the state officials ethics course will not satisfy the local officials ethics course requirements and vice versa.

#### **For Local Officials**

Cities, counties and special districts in California are required by law ( AB 1234, Chapter 700, Stats. of 2005 ), to provide ethics training to their local officials.



#### CEO Highlights – January 2017

Since last board meeting, the holiday season brought a series of **higher census**, higher acuity days. Mark Twain has had to practice surge management and up-tempo throughput in the Emergency Department, and of course careful discharge planning and care management in the ICU and Med/Surg settings. Staff has proven adept at both ends of the spectrum, from flex staffing during low census in autumn, to responding to peak volumes in winter.

In December the Medical Center honored two nurses, **Jeremy Furlong** and **Liesl Neuman**, with a prestigious national recognition, the **DAISY Award**. The DAISY Foundation takes its name from an acronym for "diseases attacking the immune system" and was created by the grateful family of a patient who wanted to recognize excellence in nursing care. Recipients are nominated by patients, families and colleagues, and chosen by a committee of nurses. This is the first year that Mark Twain has participated in the DAISY Foundation program; another group of nominees and awardees will be selected in 2017 and the program will become an ongoing annual tradition.

As mentioned in the last CEO Highlights before the holiday break, two executive positions have now been filled: Chief Medical Officer and Chief Philanthropy Officer. The **Administration Team** is now fully staffed: Bob Diehl (President), Chris Roberts (Finance), Dr. Lonnie Smith (Medical Affairs), Katherine McCoy (Nursing), Nancy Hiteshew (Quality), Margaret Pyles (Human Resources), Nicki Stevens (Business Development), and Julie Eckardt (Philanthropy).

Architects have completed a test fit of the **new Angels Camp Clinic** at the Stanislaus Avenue property location. Administration will finalize the development time table with Construction and share the plan with the philanthropic foundation. At the January 17 meeting of the foundation board, the plan is for that body to board-designate a specific portion of their funds to this project. As the project progresses through key construction milestones, funds will be released to the hospital.

January dates are set to begin having **Market Development Representatives** round on Calaveras County physicians. The MDRs will work closely with the Manager of Business Development and the CEO to coordinate messaging and listening with our doctors.

Dates are also set for a late January/early February **strategic planning retreat** with the medical center's A-Team and several planning resource leaders from Dignity Health's central California region. Key focus areas during the retreat will include topics such as inpatient growth planning, recruitment, service line expansion, clinic development, and fostering a service and hospitality culture. The work product from this retreat will come back to the board and will help to inform the early development of a Fiscal Year 18-19-20 strategic plan.
